The Department of Toxic Substances Control (DTSC) is in receipt of the *Addendum to RCRA Facility Investigation/Remedial Investigation Report, Volume 1* (Addendum) for the PG&E Topock Compressor Station in Needles, California, dated May 30, 2014. The Addendum contains additional information regarding the history and background of the PG&E Topock site and is intended to supplement the *Final RFI/RI Volume 1 – Site Background and History* that was completed in September 2007.

The draft Addendum was initially submitted in March 2013 and was reviewed by DTSC, the Department of the Interior, Tribes and stakeholders. Comments from DTSC, Tribes and stakeholders were consolidated into a response to comments (RTCs) table and discussed during a technical working group (TWG) meeting in March 2014. The revised RTCs table and additional information requested during the TWG meeting were submitted in April 2014. The Addendum contains all the revisions and additional information that were discussed during the March 2014 TWG meeting. DTSC does not have any additional comments at this time and considers the Addendum as final. Due to the long operational history of the PG&E Topock Compressor Station, should additional information become available that is relevant to the project, the Final RFI/RI Volume 1 should be supplemented or appended as necessary.
